Goresbrook Nursery has three intakes throughout the school year. Please see below which intake your child's date of birth falls under.

To be eligible for a Goresbrook Nursery place to start in:

April 2024 - your child's date of birth must fall between **1st January 2022 and 31st March 2022.**

September 2024 - your child's date of birth must fall between **1st April 2022 and 31st August 2022.**

January 2025 - your child's date of birth must fall between **1st September 2022 and 31st December 2022.**

April 2025 - your child's date of birth must fall between **1st January 2023 and 31st March 2023.**

For your child to attend our Nursery, you will need to make an application for free childcare. Without the code provided confirming eligibility, we may not be able to offer a space for your child. At present we have two sessions available - AM and PM.

When to apply:

You can apply from when your child is 1 year and 36 weeks for 15 hours free childcare:

| Your child's birthday | When they can get their hours from | Recommended time to apply |
|----------------------------|---------------------------------------|---------------------------|
| 1 September to 31 December | Term starting on or after 1 January | 15 October to 30 November |
| 1 January to 31 March | Term starting on or after 1 April | 15 January to 28 February |
| 1 April to 31 August | Term starting on or after 1 September | 15 June to 31 July |

Apply for a code:

It usually takes 20 minutes to apply via the Government Gateway account. You may find out if you're eligible straight away, but it can take up to 7 days. Once your application has been approved, you'll get a code for free childcare to give to Goresbrook School.

What you need to know:

You must reconfirm your eligibility every 3 months. If you apply more than 3 months before the term starts, you'll have to reconfirm your eligibility in your account to keep your code valid.
